

RESOLUTION

IN THE MATTER OF THE ORGANIZATION OF
THE CORNING MEMORIAL HOSPITAL DISTRICT

BE IT RESOLVED AS FOLLOWS:

Whereas, on the 4th day of June, 1946, an election was held pursuant to law in the proposed Corning Hospital District, to determine the question of whether the proposed hospital district should or should not be organized; and

Whereas, this Board of Supervisors has this 17th day of June, 1946, being the second Monday succeeding such election, canvassed the returns thereof and found and ascertained that the total number of votes cast thereat was 1496; that of such number 1224 votes were in favor of the organization of the proposed district and 272 were against such organization; and that a majority of the votes cast was and is in favor of the organization of the proposed district; tabulation as to supervisorial districts, as follows:-

Supervisorial District No. 4-----Yes: 534 No: 129

All that area in Supervisorial
District No. 5 within the exterior
boundaries of the Corning Judicial
Township -----Yes: 558 No: 95

All that area in Supervisorial
District No. 3 within the exterior
boundaries of the Corning Judicial
Township -----Yes: 124 No: 45

Now, Therefore, It Is Hereby Resolved, Order and Declared that all of the territory within the boundaries of the Corning Hospital District as heretofore fixed by the order of this Board and herein after described be, and the same is, duly organized as a hospital district under the name of "Corning Hospital District" in accordance with the Act entitled: "The Local Hospital District Law" being division 23, comprising sections 32000 to 32313 (both inclusive) of the Health and Safety Code of the State of California.

The territory above mentioned and which is hereby declared to be organized as such hospital district is situated in the County of Tehama and is bounded and described as follows, to wit:

"Beginning at a point where the Township line between Twp 24 N. R. 10 W and Twp 25 N. R. 10 " intersects the Westerly boundary line of Tehama County; thence east on a continuation of said line to the NE corner of Section 5, Twp 24 N. R. 6 W; thence Southerly one mile; thence easterly one-half mile; thence northerly one mile; thence easterly on original line to N.E. corner of Section 5, Twp. 24, N. R. 5 West; thence Northerly to the N. E. corner of Section 4, Twp 25, N. R. 5 W; thence easterly to the SE corner of Section 36, Twp 26, N. R. 4 W; thence Northerly to the south boundary of the Rosenthal Tract; thence easterly to the S. P. right of way; thence S. E. easterly along said right of way to a point where said right of way intersects the corporate limits of the City of Tehama; thence following the corporation line of the City of Tehama in a southerly, southwesterly, woutheasterly and easterly direction to the Sacramento River; thence up and along said river to the confluence of the North Fork of Mill Creek; thence up and along said North Fork of Mill Creek to a point where said

thence up and along said North Fork of Mill Creek to a point where said North Fork diverges from Mill Creek; thence up Mill Creek to a point where it intersects the Township line between Twp 26 N. R. 1 E and Township 27 N. R. 1 E; thence easterly to the boundary line between Butte and Tehama Counties."
